## DESIGN FOR A BANNER.

Specification forming part of Design No. 9,191, dated April 4, 1876; application filed March 4, 1876.  
[Term of Patent 3½ years.]

*To all whom it may concern:*

Be it known that we, EDWARD L. FENIMORE and CHRISTIAN GEIGER, of Philadelphia, Pennsylvania, have invented a Design for a Banner, of which the following is a specification:

Our design is fully shown in the accompanying photographic illustration; and consists of a banner, in the center of which is a representation of a pair of clasped hands, A, on which stands an eagle, B, with outspread wings, and holding in its beak an olive-branch. A portion of the coat-sleeve on each arm is visible, one sleeve being blue and the other gray. The remainder of both arms is hid in the folds of two American flags, D D, the Union portion of each of which is draped above the eagle. Above these draped folds is an arched scroll, E, with the word "Centennial." At each side of the banner is an ornament, consisting of a group, F, of oak and olive leaves. Below the clasped hands is a scroll, H, having in the center the word "Welcome," at one side the date "1776," and at the opposite side the date "1876." Below this, and at the bottom of the banner, is an ornament consisting of a harp, I, and branches J J, with oak-leaves and acorns. In each of the lower corners of the banner is an anchor, K.

We claim—

1. The design for an ornamental banner, comprising the clasped hands A and eagle B, as shown and described.
2. The design comprising the clasped hands A, eagle B, and draped flags D D.
3. The design comprising the clasped hands A, eagle B, draped flags D D, and side ornaments F F, as shown and described.
4. The design comprising the clasped hands A, eagle B, and top scroll E, as shown and described.
5. The design consisting of the clasped hands A, eagle B, and the lower scroll H, as shown and described.
6. The design for the banner as a whole, comprising the clasped hands A, eagle B, draped flags D D, scrolls E and H, and ornaments F, I, J, and K, substantially as shown and described.
